I, the undersigned, being of legal age and a natural person, do hereby subscribe to, Acknowledge and file the following Article of Incorporation for the purpose of creating a Corporation under the laws of the State of Florida.

ARTICLE I

The name of this corporation shall be INTRASistemas, Inc. and the initial address of this Corporation shall be c/o 15407 SW 68th Lane, Miami Florida 33193.

ARTICLE II

This corporation may engage in any activity or business permitted under the laws of the State of Florida.

ARTICLE III

The capital stock authorized, the par value thereof, and the characteristics of such stock Shall be as follows:

The consideration for all of the said stock shall be payable in cash.

ARTICLE IV

This corporation shall commence its existence immediately upon the filing of these Articles of Incorporation and shall exist perpetually thereafter unless sooner dissolved According to law.

ARTICLE V

The initial registered office of this corporation shall be at 15407 SW 68th Lane, Miami Florida 33193, with the privilege of having its locations at other places within or without the State of Florida. The initial registered agent at that address shall be Lester Moreno.

ARTICLE VI

This corporation shall have at least one directors, with the exact number to be specified by the stockholders from time to time unless the stockholders shall, by a majority vote thereafter, determine that the corporation be managed by the stockholders.

ARTICLE IX

No contract or transaction between this corporation and any other corporation, and no act of this corporation, shall in any way be affected or invalidated by the fact that any of the directors of this corporation are peculiarly or otherwise interested in, or are director or officers of, such other corporation. Any directors individually, or any firm of which any director may be a member, may be a party to, or may be peculiarly or otherwise interested in any contract or transaction of this corporation, provided the fact he or such firm is so interested shall be disclosed or shall have been know to the Board of Directors or majority thereof, and any director of this corporation who is also a director or an officer of such other corporation, or who is so interested, may be counted in determining the existence of a quorum at any meeting of Board of Directors of this corporation which shall authorize any such contract or transaction, with like force and effect as if he were not such a director or officer of such other corporation, or not so interested.

ARTICLE X

The private property of the stockholders shall not be subject to payment of the corporation debts in any extent.

ARTICLE XI


This corporation shall indemnify and insure its officers and directors to the fullest extent permitted by law either now or hereafter.
