ARTICLES OF INCORPORATION

ARTICLE I

NAME

The name of this corporation is **NO LIMIT CARPENTRY, INC.**

BUSINESS TO BE TRANSACTED

The nature of the business to be transacted by the corporation is:

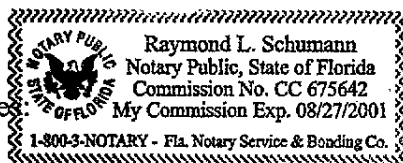




