

OF

Indemnification



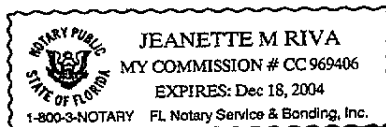
