IN WITNESS WHEREOF, the undersigned President of the Corporation have executed these Articles of Amendment this 15 day of November, 2017.

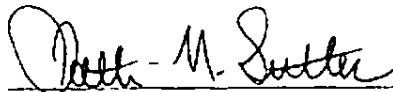
