

ARTICLES OF INCORPORATION

OF

CANCUN'S OF DESTIN, INC.



ARTICLE I NAME

The name of the corporation shall be CANCUN'S OF DESTIN, INC., and its principal place of business shall be in the county of Walton, Florida, but it shall have the power and authority to establish branch offices at such places as may be designated by the Board of Directors.

ARTICLE II DURATION

The period of duration for this Corporation is perpetual.

ARTICLE III PURPOSE

The purpose of the Corporation is to engage in the restaurant business and any other business as permitted under the laws of the United States and the State of Florida, and to do everything necessary, proper, advisable, or convenient for the accomplishment of any of the purposes herein set forth.
