ARTICLES OF INCORPORATION

SUPERIOR RESTORATION SERVICES, INC.

The undersigned incorporators, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopt the following Articles of Incorporation.

ARTICLE I NAME

The name of the corporation shall be: Superior Restoration Services, Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business of this corporation shall be: 4044 W. Lake Mary Blvd., Lake Mary, Florida 32746


ARTICLE III PURPOSE OR PURPOSES

The purpose or purposes for which the corporation is organized are to engage in the building, repairing and restoration of any type of structure, private or commercial, and to subcontract the same to professionals in related fields, as well to do everything necessary, proper, advisable, or convenient for the accomplishment of said purpose and to do all other things incidental to them or connected with them or any other business that are not forbidden by Florida corporation law or by other law, or by these articles of incorporation, and to carry out the said purposes in any state, territory, district, or possession of the United States, or in any foreign country, to the extent that these purposes are not forbidden by the law of the state, territory, district, or possession of the United States, or by the foreign country.

ARTICLE IV SHARES

The aggregate number of shares of stock and its par value that this corporation is authorized to have outstanding at any one time is: 100 shares of Capital Stock with a par value of \$5.00 per share.

Initial issue: 100 shares of the Capital Stock of the corporation shall be issued for cash at a par value of \$5.00 per chare.



Stated capital: The sum of the par value of all shares of Capital Stock of the corporation that have been issued shall be the stated capital of the corporation at any particular time.

Dividends: The holders of the outstanding capital stock shall be entitled to receive, when and as declared by the Board of Directors, dividends payable either in cash, in property or in shares of the capital stock of the corporation.

No classes of stock: The shares of the corporation are not to be divided into classes.

No share in series: The corporation is not authorized to issue shares in series.

ARTICLE V TERM OF EXISTENCE

This corporation is to exist perpetually.

ARTICLE VI INCORPORATORS, OFFICERS, DIRECTORS

The initial board of directors and incorporators shall consist of two (2) members, who need not be residents of the State of Florida or shareholders of the corporation.
