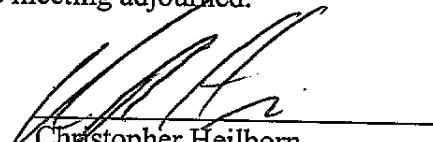

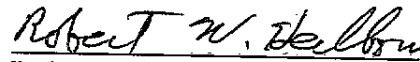
A vote was taken which showed 100 % shares in favor.
