

ARTICLE X - AMENDMENT

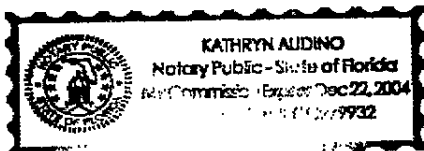


