Share #3 for 33 1/3 shares is issued to Saad S. Kawasmeh.

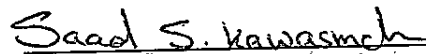
Share #4 for 11 1/3 shares is issued to Mursi Kawasmy.

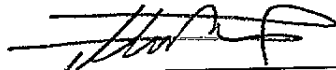
THIRD: The date of each amendment's adoption: January 11, 2002
