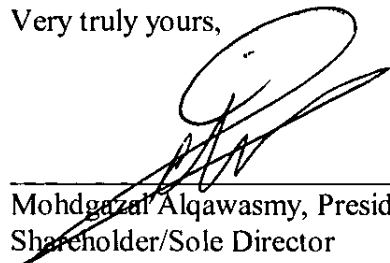

SECOND: The document number of the Corporation is P01000004263.

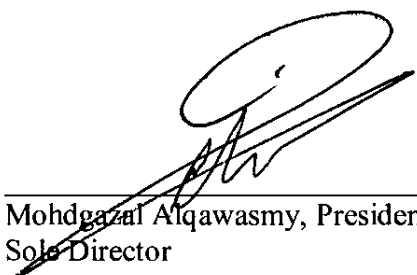
