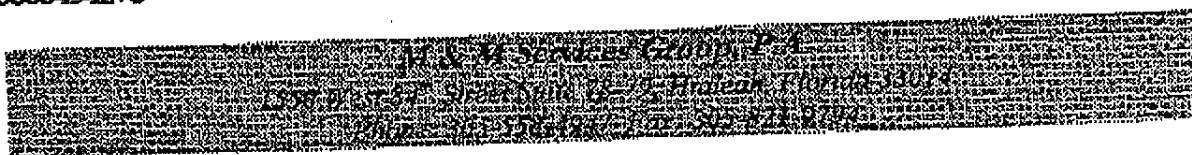

ARTICLE X- INCORPORATOR

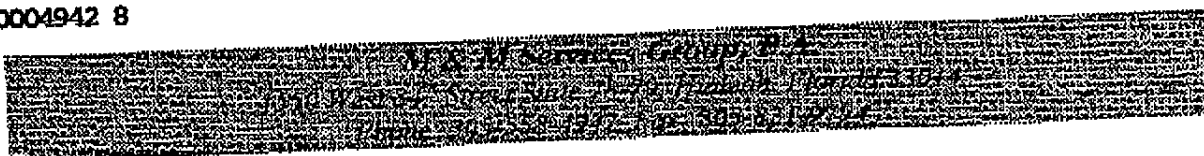
