Articles of Incorporation of Kirshy Properties, Inc.

ARTICLE I

NAME

The name of the corporation is Kirshy Properties, Inc.

EFFECTIVE DATE

ARTICLE II

PRINCIPAL OFFICE AND INITIAL REGISTERED AGENT
