

The undersigned, who is duly licensed to practice law in the State of Florida, desires to form a professional corporation in accordance with Chapter 607, Florida Statutes, and the Florida Professional Service Corporation Act, adopts the following Articles and hereby present these Articles of Incorporation for the formation of the corporation.

Article I Name

The name of this corporation is:

Article II Formation and Duration

The corporation shall be deemed formed upon the filing of these Articles with the Florida secretary of state's office. The corporation's existence shall be perpetual.

Article III Purpose
