The undersigned, who is duly licensed to practice law in the State of Florida, desires to form a professional corporation in accordance with Chapter 607, Florida Statutes, and the Florida Articles of Incorporation for the formation of the corporation.

Article I Name

The name of this corporation is:

Article II Formation and Duration
