Articles of Incorporation

of

MS HANDLING, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

- Article 1: Name. The name of the Corporation is: MS HANDLING, INC.
- Article 2: Duration. The duration of the Corporation is perpetual.
- Article 3: Purpose. The general purposes for which the Corporation is organized are the following:
 - A. To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.
 - B. To do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.
- Article 4: Capital Stock. The aggregate number of shares which the Corporation is authorized to issue is 100 (One Hundred) shares of common stock. Such shares shall be of a single class and shall have a par value of \$1.00 (One Dollar) per share. The initial Shareholder is: MARK S. HAND and he shall retain 100% ownership of the stock.

The number of Directors may be increased from time to time in accordance with the bylaws but shall never be less than 1 (One). - Article 7: Incorporator. The name and address of the incorporator is: MARK S. HAND, 229 CHANDLER ROAD, NOKOMIS, FL 34275.
