



In compliance with the requirements of Chapter 621 and 607 of the Florida Statutes, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

**ARTICLE I CORPORATE NAME.**

The name of this corporation is Cindy Schmidt, P.A.

**ARTICLE II PRINCIPAL OFFICE.**
