The undersigned, for the purpose of forming a corporation under the laws of the State of Florida, do hereby adopt the following Articles of Incorporation:

ARTICLE ONE NAME

The corporate name shall be: DSX International Corporation

ARTICLE TWO CORPORATE DURATION

The duration of the corporation is perpetual.
