

Article I Name

The name of the Corporation is Alan Lowell Consultants, Inc.

Article II Duration

The Corporation shall commence its existence on February 1, 2001 and shall have perpetual existence.

Article II Purpose

The nature of the business to be promoted and carried on, is to engage in any lawful activity for which Corporations may be organized under the General Corporation laws of the State of Florida. The Corporation is organized for the purpose of providing, managing and operating various hearing aid facilities. To provide various services relating to the operations of the business as from time to time shall be deemed appropriate, including but not limited to consulting services.
