

**ARTICLES OF INCORPORATION
FOR
K.L. McCaul Construction, Inc.**

ARTICLE ONE- NAME OF CORPORATION

The name of the Corporation is: **K.L. McCaul Construction, Inc.**

ARTICLE TWO- DURATION

This corporation shall have perpetual existence commencing on the date of filing of these Articles of Incorporation with the Department of State.


