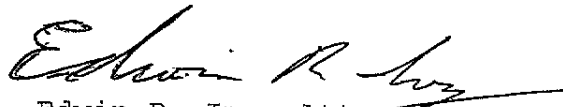

In compliance with the requirements of F. S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation is Buck Enterprises, Inc.

ARTICLE II

The existence of the corporation shall begin on the date the Articles of Incorporation are filed with the State of Florida.

ARTICLE III

The street address of the principal office of the Corporation is 818 Ellwood Ave, Orlando, Florida 32804.

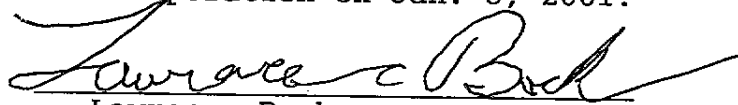

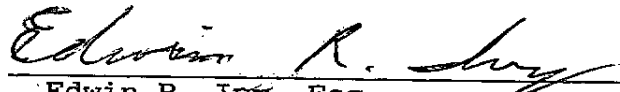
ARTICLE VIII
