ARTICLES OF INCORPORATION

OF

ELLIS W. PEETLUK, P.A.

The undersigned subscriber(s) to these articles of incorporation, being duly licensed to practice as an Attorney at Law under the laws of the state of Florida, adopt(s) these articles to form a corporation under the Professional Service Corporation and Limited Liability Company Act, F.S. Chapter 621, and other laws of the state of Florida.

ARTICLE I. NAME

ARTICLE II. PRINCIPAL OFFICE

ARTICLE IX. RESTRAINT ON ALIENATION OF SHARES

If any shareholder becomes legally disqualified to practice as an Attorney at Law in the state of Florida, is elected to a public office, or accepts employment that places restrictions or limitations on the continuous rendering of such professional services, that shareholder's shares of stock shall immediately become subject to purchase by the professional service corporation in accordance with the bylaws adopted by the shareholders.

ARTICLE X. AMENDMENT

The corporation reserves the right to amend or repeal any provisions in these articles of incorporation in the manner provided by law. Any right conferred on the shareholders is subject to this reservation.
