The Undersigned, acting as Incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation.

1. The name of the corporation is as follows:

3. The purpose is to engage in any activities or business permitted under the laws of the United States and the state of Florida. The specific purpose is real estate sales.


