**ARTICLE I - NAME**

The name of this corporation is GCSK, Inc., and the principal office or mailing address of the corporation is 2321 Indian Mound Trail, Kissimmee, FL 34746.

**ARTICLE II - DURATION**

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

**ARTICLE III - PURPOSE**

This corporation is organized for the purpose of transacting any or all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes, as now exists or may after be amended.

**ARTICLE IV - CAPITAL STOCK**

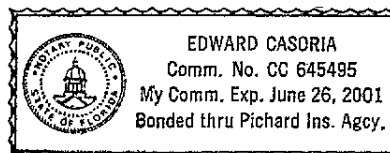


