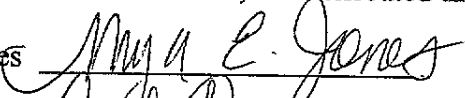

**ARTICLE VI:** The liability of the directors of the corporation for monetary damages shall be eliminated to the fullest extent permissible under Florida law.
