# Articles of Incorporation. Of Power Marketing Source, Inc.

The undersigned, are the subscribers to these Articles of Incorporation, under the provisions of 607 F.S. Florida General Corporation Act.

#### ARTICLE I NAME AND ADDRESS

The name of the corporation is: Power Marketing Source, Inc., The physical address of the corporation is 11232 108<sup>th</sup> Lane North, Largo, Florida 33778.

#### ARTICLE II DURATION

This corporation shall exist perpetually, commencing on the date of the Incorporators execution of these articles which has been delivered to the Secretary of State of Florida within five days of acceptance and filing of these Articles by the Secretary of State of the State of Florida.

# ARTICLE III PURPOSE OF BUSINESS

The purpose of this corporation is to engage in any activity of businesses permitted under the laws of the United States of America and of the State of Florida.

### ARTICLE IX PREEMPTIVE RIGHTS

Each holder of the common stock of this corporation shall have the first right to purchase shares of any other securities that the corporation may issue from time to time, including

This right is waived by any holder of the common stock who does not exercise it and pay for the stock available for purchase pursuant to such preemptive rights, within thirty days of his receipt of a written notice from this corporation stating the price, terms and conditions of the issue of shares and inviting him or her to exercise his preemptive rights.

## ARTICLE X INDEMNIFICATION

The corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law

#### ARTICLE XI BYLAWS

The Board of Directors shall adopt the initial Bylaws. The power to alter, amend or repeal the Bylaws or adopt new Bylaws is vested in the Board of Directors, subject to repeal or change by action of the shareholders.

#### ARTICLE XII <u>AMENDMENT</u>

These Articles of Incorporation may be amended in the manner provided by law and the Bylaws of this Corporation.

# ARTICLE XIII INFORMAL SHAREHOLDERS ACTION

The holders of not less than a majority of the issued and outstanding shares of the voting stock of the corporation may act by written agreement without a meeting, as provided in Section 606.394 F.S. and the Bylaws.
