## ARTICLES OF INCORPORATION OF THE STRIPED APRON, INC.

THE UNDERSIGNED, acting as sole incorporator of THE STRIPED APRON, INC. under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

#### ARTICLE I NAME
