

OF

The undersigned subscriber to these Articles of Incorporation, Debora D. Reeder, being a natural person competent to contract, hereby acknowledges and files these ARTICLES OF INCORPORATION in the Office of the Secretary of State of the State of Florida in order to form a Corporation for profit under the laws of the State of Florida.

ARTICLE I
CORPORATE NAME

The name of this Corporation is ICSTARZ, INC. The principal office and mailing address of the corporation is 9456 Sweetgrass Way, Naples, Florida 34108.

ARTICLE II
DURATION


The power to adopt, alter, amend or repeal By-Laws shall be vested in the Board of Directors and the Shareholders in the manner provided by the laws of the State of Florida.


