ARTICLE I - NAME AND PRINCIPAL LOCATION

The name of this corporation is "Flouroscopic Resources, Inc." The principal location of the corporation is 17 Whitehall Court, Flagler Beach, Florida 32136.

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE

The general nature and purposes of the business to be transacted, promoted and carried on by the corporation are as follows: distribution and sale of medical imaging equipment, and engaging in any act, duties or business permitted under the laws of the United States and the State of Florida.
