ARTICLE I. NAME

The name of the corporation is: The Florida Election Center, Inc.

ARTICLE II. PRINCIPAL OFFICE

The principal place of business and mailing address for the Florida Election Center, Inc. is: 7484 Skipper Lane, Tallahassee, Florida, 32311.

ARTICLE III. PURPOSE

The purpose for which the Florida Election Center, Inc. is organized is to promote and assist citizen participation in our democracy. Citizens include individuals, businesses, public officials, candidates, political action committees, political parties, or any other affiliation of persons desiring to participate in the process by supporting or opposing candidates, ballot issues, or other referenda. The center is not organized for the purpose of directly or indirectly supporting specific candidates or issues as defined by the Florida Election Code, Chapters 97 through 106, Florida Statutes.

ARTICLE IV. SHARES

The number of shares of stock which the corporation is authorized to issue is one.

ARTICLE V. INITIAL OFFICERS AND DIRECTORS

Initially, the corporation shall have an Executive Director who shall also be the initial director of the corporation and serve as its Secretary and Treasurer.

ARTICLE VI. REGISTERED AGENT

ARTICLE VII. INCORPORATOR
