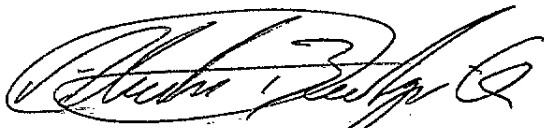

This corporation reserves the right to amend or repeal any provisions in this articles of incorporation or any amendment ,any right conferred upon the shareholders is subject to this reservations.

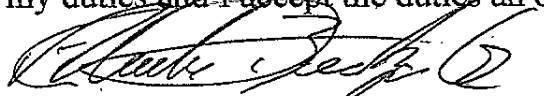
