## ARTICLES OF INCORPORATION OF MURRAY & RATLIFF, P.A. SECRETARY OF STATE TALLAHASSEE, FLORIDA

The undersigned; for the purpose of forming a corporation under the FLORIDA GENERAL CORPORATION ACT hereby adopts the following Articles of Incorporation:

#### ARTICLE ONE NAME
