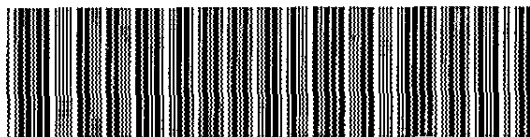



FIRST: Amendments adopted:



SECOND: The date of each amendment's adoption: June 1, 2001.


