ARTICLES OF INCORPORATION

The undersigned, acting as incorporators of a corporation under the Florida General Corporation Act, adopt the following Articles of Incorporation for such corporation:

- 1. The name of the corporation is I-75 SPEEDWAY, INC.
- 2. The address of the corporation is 3838 Tamiami Trail North, Suite 416, Naples, FL 34103
- 3. The period of its duration is perpetual.
- 4. The purpose or purposes for which the corporation is organized are to engage in any activity or business permitted under the laws of the United States and the State of Florida.
- 5. The corporation shall have authority to issue seventy-five hundred shares, all of one class, one dollar par value.
- 6. The address of its initial registered office is Gulf Coast National Bank, 3838 Tamiami Trail
 North, Suite 416, Naples, Florida and the name of its initial registered agent at said address
 is Christian B. Felden.
- 7. The initial Board of Directors shall consist of one (1) members, who need not be a resident of the State of Florida or shareholder of the corporation.
- 8. The names and addresses of the persons who shall serve as directors until the first annual meeting of shareholders, or until their successors shall have been elected and qualified, are as follows: Simon Vainer, 3838 Tamiami Trail North, Suite 416, Naples, FL 34103

purchase, at prices, terms and conditions as shall be fixed by the Board of Directors, such of the shares of the stock of this corporation as may be issued for money, or any property or services from time to time, in addition to that stock authorized and issued by the corporation. The preemptive right of any holder is determined by the ratio of the authorized and issued shares of common stock held by the holder and all shares of common stock currently authorized and issued.
