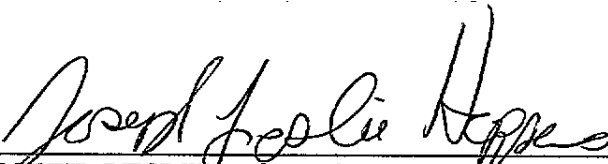
ARTICLE IX - BYLAWS

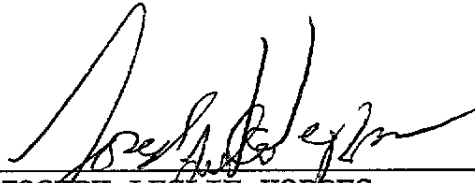
