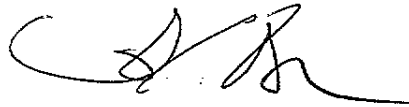
### ARTICLE VIII:

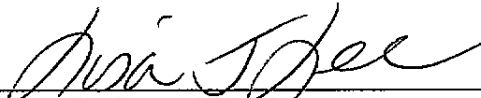
