The undersigned, acting as incorporator of this Corporation pursuant to Chapter 607 of the Florida Statutes, hereby forms a corporation for profit under the laws of the State of Florida and adopts the following Articles of Incorporation for such Corporation:

ARTICLE I - NAME OF CORPORATION

The name of this Corporation shall be SPERRING & EDWARDS CONSTRUCTION SERVICES, INC.

ARTICLE II - PRINCIPAL OFFICE AND MAILING ADDRESS

The principal office of this Corporation shall be located at 499 Spinnaker Drive, Marco Island, FL 34145. The mailing address of the Corporation shall be 499 Spinnaker Drive, Marco Island, FL 34145.

ARTICLE III - DATE OF EXISTENCE

This Corporation shall exist perpetually, commencing on filing of these Articles of Incorporation.

ARTICLE IV - CAPITAL STOCK

The maximum number of shares of capital stock that this Corporation is authorized to issue and have outstanding at any one time is one hundred thousand (100,000) shares of voting common stock having a par value of One Dollar (\$1.00) per share.

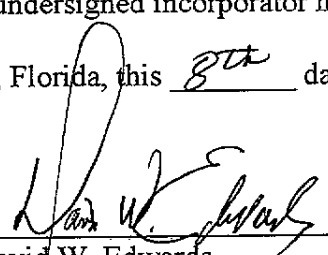

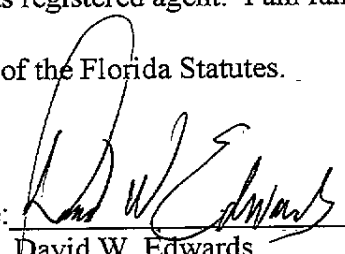
