The existence of this corporation shall be perpetual.

Article III - Purpose

Article IV - Capital Stock

This corporation is authorized to issue 1000 shares  
of one (\$ 1.00 ) par value common  
stock.

Article V - Preferences, Limitations and  
Relative Rights of Shares of Capital Stock

Section 1. Rights upon Liquidation or Dissolution.

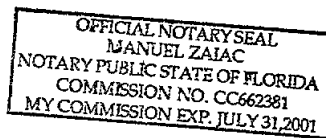
