PURPOSES

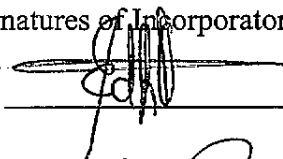

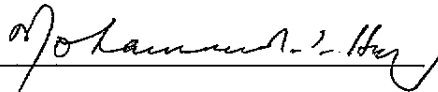
