

**ARTICLES OF INCORPORATION
OF
SIGNS BY RPM GRAPHICS, INC.**

The undersigned, for the purpose of forming a corporation under Section 607.0202 of the Florida Business Corporation Act, does hereby certify as follows:

ARTICLE I

Corporate Name and Address

The name of the Corporation is Signs by RPM Graphics, Inc., and the address of the principal office and mailing address of the Corporation is 10681 Deer Run Farms Road, Fort Myers, Florida 33912.

ARTICLE II

Corporate Purpose

The Corporation is organized to transact any and all lawful business authorized by the Florida Business Corporation Act.

ARTICLE III

Authorized Stock

The aggregate number of shares of the Corporation shall be 1,000, all of which are to be voting common stock having a par value of \$1.00 per share.

ARTICLE IV

Registered Office and Registered Agent

The street address of the initial registered office of the Corporation in the State of Florida shall be 10681 Deer Run Farms Road, Fort Myers, Florida 33912. The name of the initial registered agent of the Corporation at the registered office shall be Douglas E. Moff.

ARTICLE V

Initial Board of Directors

The initial Board of Directors of the Corporation shall be comprised of two people. The Directors shall be elected annually in accordance with the By-laws. The number of Directors may be increased or decreased from time to time in accordance with the By-laws, but shall never be less than one.
