The undersigned Incorporator, a natural person, competent to contract, hereby makes, subscribes, acknowledges and files these Articles of Incorporation for the purpose of creating a corporation for profit under the laws of the State of Florida.

ARTICLE I

NAME

The name of the Corporation is:

MARKET RIGHT RESEARCH, INC.

ARTICLE II

NATURE OF BUSINESS

The Corporation is authorized to engage in the business of Market Research and all other lawful business and any other transactions permitted under the laws of the United States and the State of Florida.

The Corporation shall have as many branches as may be deemed necessary.

ARTICLE III

CAPITAL STOCK

The Corporation shall be authorized to issue shares of common stock

The maximum number of shares of common stock that the Corporation is authorized to have outstanding at any time (100) shares at \$1.00 par value.

The Corporation shall be authorized to issue shares of preferred stock. The maximum number of shares of preferred stock that the Corporation is authorized to have outstanding at any time is (100) shares at \$1.00 par value.

The preferred stocks issued by the Corporation shall be non-voting, non-cumulative in the payment of dividends and shall entitle the owner to a preference equal to seventy-five percent (75%) of the fair market value of the assets of the Corporation in the event of liquidation.

Authorized capital stock may be paid for in cash, services or property, at a just value to be fixed by the stockholders of the corporation any regular or special meeting.

ARTICLE IV

INITIAL CAPITAL

The amount of capital with which the Corporation shall begin business is not less than One Hundred (\$100.00) Dollars.

ARTICLE V

TERM OF EXISTENCE

The Corporation shall have perpetual existence which shall commence at the time of filing of these Articles of Incorporation with the Secretary of the State of Florida.
