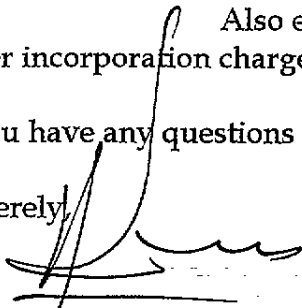

The undersigned incorporator to these Articles of Incorporation, by these Articles form a corporation for profit, pursuant to the laws of the State of Florida.

FIRST. The name of the corporation is **Miami Alliance, Inc.**

SECOND. The period of duration of the corporation is perpetual.

THIRD. The purpose is to engage in any activities or business permitted under the laws of the United States and of the State of Florida.

FOURTH. The aggregate number of shares of Capital Stock which the Corporation has authority to issue is one hundred thousand (100,000) all of which shall be one class of common stock having a par value of \$0.01.

FIFTH. The address of its initial registered office is 4141 North Miami Avenue, Suite 210, Miami, Florida 33127, and the name of the initial register agent at such address is Roberto G. Bravo.

SIXTH. The initial Board of Directors will consist of one (1) director whose name and address is: Roberto G. Bravo, 2235 Arch Creek Drive, North Miami, Florida 33181.

SEVENTH. The name and address of the incorporator is: Roberto G. Bravo, 2235 Arch Creek Drive, North Miami, Florida 33181.

EIGHTH. Preemptive Rights shall be as follows: each shareholder of stock of this Corporation shall be entitled to full preemptive rights to purchase unissued or treasury stock of the Corporation convertible into or carrying a right to subscribe to acquire shares of any such unissued stock or treasury stock.

NINTH. The initial street address of the principal office of the Corporation in the State of Florida is: 4141 North Miami Avenue, Suite 210, Miami, Florida 33127.

TENTH. The Corporation shall indemnify incorporators, officers and directors to the full extent permitted by law.

ELEVENTH. A. The Corporation adopts all contracts made on its behalf by the aforementioned incorporators.

B. The Corporation authorizes its directors to reimburse the aforementioned incorporator for any and all expenses incurred on behalf of the Corporation, prior to its incorporation and for any and all expenses incurred in the organization and formation of the Corporation.
C. The directors of this Corporation shall have the sole discretion to determine the expenses for which the afore-mentioned incorporator shall be reimbursed.

TWELVE. The Corporation reserves the right to amend or repeal any provision contained in the Articles of Incorporation or any amendment to the Articles of Incorporation.

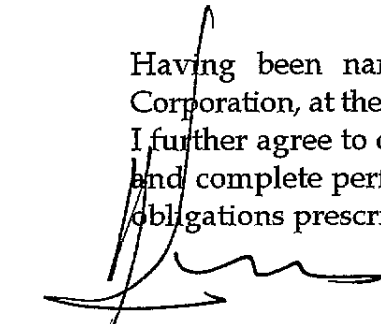
