**ARTICLES OF INCORPORATION
OF

The undersigned hereby adopt(s) the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida:

ARTICLE I - NAME

The name of the corporation is BONITA JONES PEABODY, P.A.

ARTICLE II - DURATION

This corporation shall exist perpetually.

ARTICLE III - PURPOSE

This corporation is formed as a law firm to provide legal advice, assistance and counseling to and representation of individuals, other corporate entities, partnerships, and joint ventures and any and all legally recognized business entity within or without the State of Florida. This Corporation also have the right to hold, own, rent, lease, buy, sale or manage on behalf of itself or it's client(s) real and/or personal property, borrow and/or lend money, and invest. Further, this corporation is organized for the purpose of transacting any and all lawful business for which corporations may be incorporated for under Florida Statutes chapters 621 and 607 as is or hereafter amended as well as any activity or practice of law for which attorneys licensed within or without the State of Florida may engage.

ARTICLE IV - STATED CAPITAL

The corporation is authorized to issue 1,000 shares of stock with a par value of \$10.00 per share.

ARTICLE VII – BY-LAWS

The power to adopt, alter, amend or repeal bylaws shall be vested in the board of directors and the shareholders, but the board of directors may not alter, amend or repeal any bylaws adopted by the shareholders if the shareholders provide that the bylaws shall not be altered, amended or repealed by the board of directors.

The corporation shall have one (1) director initially. The number of directors may hereafter be increased or decreased from time to time in accordance with the bylaws of the corporation.

These articles of incorporation may be amended at any time by a vote of the majority of the voting stock of the corporation outstanding, at any regular meeting of the shareholders or at any special meeting of the shareholders called for that purpose.

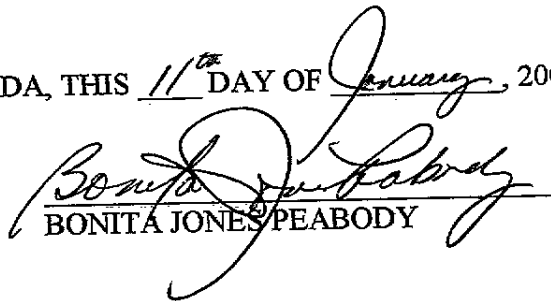

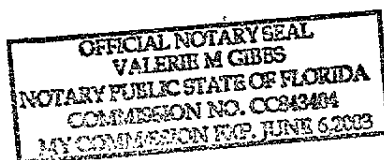

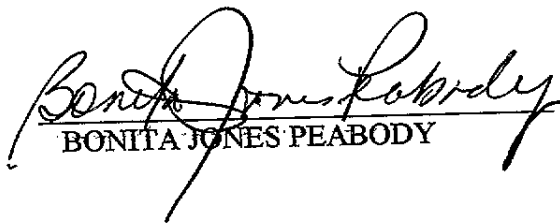
