ARTICLES OF INCORPORATION OF SALON VIS-A-VIS, INC.

The undersigned, acting as incorporators of a corporation under the laws of the State of Florida, and Florida Statutes. Chapter 607, hereby set forth and declare:

CHARTER

Article I

The name of the corporation shall be SALON VIS-A-VIS, INC.

Article II

The corporation may engage in any activity or business permitted under the laws of the United States and of the State of ______ Florida.

Article III

The aggregate number of shares which the corporation shall have authority to issue shall be 100 shares of \$5.00 par value common stock, which shall be nonassessable and held, sold, and paid for at such time and in such manner as the Board of Directors may from time to time determine.
