ARTICLES OF INCORPORATION

OF

ARTICLE I - NAME

The name of the corporation is Schmitt Custom Construction, Inc., 1030 San Raphael Road SW, Palm Bay, Florida 32908 (Principal Office of Registered Agent).

ARTICLE II - DURATION -
