The name of the corporation is IRENE EXPERIENCED CLOTHING, INC.

ARTICLE II - PURPOSE

This corporation may engage in any activity or business permitted under the laws of the United States and Florida.

ARTICLE III - AUTHORIZED SHARES

The maximum number of shares that the corporation is authorized to have outstanding at any time is five thousand (500) shares of common stock having a par value of \$1.00 per share.
