# ARTICLES OF INCORPORATION

FILED FILED I, the undersigned, being of legal age and a natural person, do hereby subscribe to acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

## **ARTICLE I**

The name of this corporation shall be OKEE HOLDINGS, INC., and the initial address of this corporation shall be 119 Martin Street, Indian Harbor Beach, Florida 32937.

#### **ARTICLE II**

This corporation may engage in any activity or business permitted under the laws of the State of Florida.

#### ARTICLE III

The capital stock authorized, the par value thereof, and the characteristics of such stock shall be as follows:

The consideration for all of the said stock shall be payable in cash, property, real or personal, labor or services in lieu of cash, at a just valuation to be fixed by the Board of Directors of the corporation.

Upon the sale for cash of any new stock of the same kind, class or series as that which he already holds, every shareholder of this corporation shall have the pre-emptive right to purchase his pro rata share thereof at the price which it is offered to others, whether or not in excess of par. Fractional shares need not be issued on account of this provision.

## ARTICLE IV

This corporation shall commence its existence immediately upon the filing of these Articles of Incorporation and shall exist perpetually thereafter unless sooner dissolved according to law.

# ARTICLE V

The initial registered office of this corporation shall be at 2115 Palm Bay Road, NE, Sutie 1E, Palm Bay, Florida 32905, with the privilege of having its offices and branch offices at other places within or without the State of Florida. The initial registered agent at that address shall be Roy A. Alterman.
