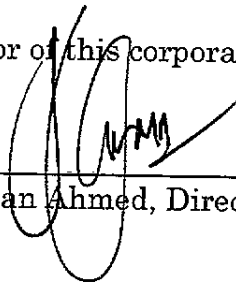

Article I of the Articles of Incorporation of GLOBAL MEDICAL NETWORKS, INC. was amended by the corporation's board of directors on April 17, 2001. The corporation is filing these Articles of Amendment to Articles of Incorporation pursuant to F.S. 607.1005 and F.S. 607.1006.

1. The name of the corporation is GLOBAL MEDICAL NETWORKS, INC.
2. Article I of the Articles of Incorporation of GLOBAL MEDICAL NETWORKS, INC. was amended as follows:
"The name of this corporation shall be ADVANCED MEDICAL APPLICATIONS, INC."
3. The foregoing Amendment to Articles of Incorporation was duly adopted by the board of directors on April 17, 2001.
4. The foregoing Amendment to Articles of Incorporation do not require shareholder approval because the corporation has not yet issued shares.
