Pursuant to Section 607.1006 of the Florida Business Corporation Act, the undersigned President of Vida Vision Acquisition Co., a Florida corporation (the "Corporation"), hereby executes and submits for filing with the Department of State of the State of Florida these Articles of Amendment to the Articles of Incorporation of the Corporation to read as follows:

ARTICLE I

The name of this corporation is **Vida Vision Communications, Inc.**

Except as hereby amended, the Articles of Incorporation of the Corporation shall remain the same.

This Amendment shall be effective upon its filing with the Florida Department of State.
