## **ARTICLES OF INCORPORATION**

#### SOL CARIBE, INC.

The undersigned, acting as Sole Incorporator of a Corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such Corporation:

## **FIRST**

The name of the Corporation is: SOL CARIBE, INC.

The period of duration of the Corporation is perpetual.
