The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation, for profit, under the laws of the State of Florida.

Article I

The name of the corporation is etelix.com, Incorporated.

Article II

This corporation is to exist perpetually unless dissolved in accordance with the law of the State of Florida.

Article III

This corporation may engage in any activities or businesses permitted under the laws of the United States of America and the laws of the State of Florida.

Article IV

The aggregate number of shares of stock which this corporation shall have authority to issue is One Hundred Thousand (100,000) shares of no par value, which shall be designated "common stock," and 100,000 shares of preferred stock. The Board of Directors shall have the authority to determine the rights and voting power of the preferred stock.
